

Compensation of Elected Officials of the Village of Hoffman Estates

* The sum of \$100.00 per day for any regular meeting of the Board of Trustees or any regular standing committee of the Board of Trustees, and for any special meeting of the Board of Trustees called under section 2-2-3 of the Hoffman Estates Municipal Code or any special meeting of a standing committee of the Board of Trustees or special committee meetings of the Board of Trustees as called under section 2-2-8 of the Hoffman Estates Municipal Code.

** Effective with all appointments or elections on or after May 1, 2009, the annual compensation and additional compensation went up to \$5,000.00 and \$100.00 per day respectively for the Village Trustees. Three of the current Trustees were sworn in May, 2007 and three Trustees were sworn in May, 2009.

*** The Village Clerk shall be paid the sum of \$100.00 per day for any special meeting of the Board of Trustees called under section 2-2-3 of the Hoffman Estates Municipal Code.

**** Effective with all appointments or elections of Trustees on or after May 1, 2009, the annual compensation for the Liquor Control Commission was established at \$250 per month. Each Trustee serves a four month term on the Liquor Control Commission annually.

Sec. 3-1-3. Executive duties--Compensation.

The President of the Board of Trustees shall perform the duties and exercise the powers conferred upon the mayor of a city. The President shall devote such time to the duties of his/her office as the faithful discharge thereof may require, and shall receive as compensation therefore an annual salary of \$15,000.00. Said amount shall be payable in 12 equal installments on the first of each month. In addition, the Village President shall, upon taking office by appointment or election on and after May 1, 1993, be paid the sum of \$50.00 per day for any regular meeting of the Board of Trustees or any regular standing committee of the Board of Trustees, and for any special meeting of the Board of Trustees called under Section 2-2-3 of the Hoffman Estates Municipal Code or any special meeting of a standing committee of the Board of Trustees or special committee meetings of the Board of Trustees as called under Section 2-2-8 of the Hoffman Estates Municipal Code. The President of the Board of Trustees may exercise the same veto powers, and with like effect, as the mayor of a city; and the Board of Trustees may pass ordinances over such veto and in like manner as a city council.

In addition, the Village President shall, upon taking office by appointment or election on and after May 1, 2009, shall receive as compensation an annual salary of \$25,000.00. Said amount shall be payable in 12 equal installments on the first of each month. In addition, the Village President shall, upon taking office by appointment or election on and after May 1, 2009, be paid the sum of \$100.00 per day for any regular meeting of the Board of Trustees or any regular standing committee of the Board of Trustees, and for any special meeting of the Board of Trustees called under Section 2-2-3 of the Hoffman Estates Municipal Code or any special meeting of a standing committee of the Board of Trustees or special committee meetings of the Board of Trustees as called under Section 2-2-8 of the Hoffman Estates Municipal Code. The President of the Board of Trustees may exercise the same veto powers, and with

like effect, as the mayor of a city; and the Board of Trustees may pass ordinances over such veto and in like manner as a city council.

Sec. 3-2-6. Compensation.

Each member of the Board of Trustees shall receive compensation in the amount of \$2,400.00. Said amount shall be payable in 12 equal installments, on the first of each month. In addition, each member of the Board of Trustees who takes office by appointment or election on and after May 1, 1991, but prior to April 30, 1993, shall be paid the sum of \$50.00 per meeting in which he is in attendance for any special meeting of the Board of Trustees called under Section 2-2-3 of the Hoffman Estates Municipal Code or any special meeting of a standing committee of the Board of Trustees or special committee meeting of the Board of Trustees as called under Section 2-2-8 of the Hoffman Estates Municipal Code. In addition, each member of the Board of Trustees who takes office by appointment or election on and after May 1, 1993 shall be paid the sum of \$50.00 per day for any regular meeting of the Board of Trustees or any regular standing committee of the Board of Trustees, and for any special meeting of the Board of Trustees called under Section 2-2-3 of the Hoffman Estates Municipal Code or any special meeting of a standing committee of the Board of Trustees or special committee meetings of the Board of Trustees as called under Section 2-2-8 of the Hoffman Estates Municipal Code.

In addition, each member of the Board of Trustees who takes office by appointment or election on and after May 1, 2009 shall receive compensation in the amount of \$5,000.00. Said amount shall be payable in 12 equal installments, on the first of each month. In addition, each member of the Board of Trustees who takes office by appointment or election on and after May 1, 2009 shall be paid the sum of \$100.00 per meeting in which he is in attendance for any special meeting of the Board of Trustees called under Section 2-2-3 of the Hoffman Estates Municipal Code or any special meeting of a standing committee of the Board of Trustees or special committee meeting of the Board of Trustees as called under Section 2-2-8 of the Hoffman Estates Municipal Code.

Sec. 3-3-17. Compensation.

The compensation of the Village Clerk shall be the sum of \$46,794.00 per annum from May 1, 2001, to April 30, 2002; \$48,666.00 per annum from May 1, 2002 to April 30, 2003; \$50,612.00 per annum from May 1, 2003 to April 30, 2004; and \$52,637.00 per annum thereafter to be paid out of the General Fund from the proper appropriation for all services, including attending meetings, keeping minutes, records, seal and files and recording the same; for his keeping and attending his/her office; and for his/her other clerical duties relating to the general business of the Village keeping and attending his/her office; and for his/her other clerical duties relating to the general business of the Village. Said salary shall be paid in monthly installments on the first of each month. The Village Clerk shall, upon taking office by appointment or election on or after May 1, 2001, be paid the sum of \$50.00 per day for any special meeting of the Board of Trustees called under Section 2-2-3 of the Hoffman Estates Municipal Code. In addition, the Village Clerk shall, upon taking office by appointment or election on or after May 1, 2009, be paid the sum of \$100.00 per day for any special meeting of the Board of Trustees called under Section 2-2-3 of the Hoffman Estates Municipal Code.

Sec. 8-3-3. Local liquor control commission.

The Village of Hoffman Estates Local Liquor Control Commission shall consist of three members, the Village President and two Village Trustees. The President of the Village of Hoffman Estates shall serve as chairman of the Local Liquor Control Commission. Two Village Trustees shall serve as members as determined by most senior in service and most junior in service as of January 1 of each year for a term of January through April of each year; and as determined by second most senior in service and second most junior in service as of May 1 of each year for a term of May through August of each year; and as determined by third most senior in service and third most junior in service as of September 1 of each year for a term of September through December of each year. The Chairman of the Local Liquor Control Commission shall receive \$800.00 per month compensation and each of the other two members shall receive \$250.00 per month compensation.

A vacancy shall be considered for these purposes as the most junior position and if a vacant position is required for service, the next most senior position shall serve. It is understood that in some years, a Trustee may be required to serve more than one term.

Sec. 4-3. The city council of each city and the president and board of trustees of each village and incorporated town and the county board are authorized to fix and pay compensation to the local liquor control commissioner of the particular city, village, incorporated town or county, as the case may be, and compensation to such deputies, assistants or employees as may be deemed necessary for the proper performance of the duties vested in him.
